

Avista 100 Winners of \$100 Summer Promotion Go Paperless & Win Official Rules

No purchase or payment of any kind is necessary to be eligible.

ELIGIBILITY: The Avista 100 Winners of \$100 Summer Promotion – Go Paperless & Win Promotion (“Promotion”) is open to legal residents of Washington, Oregon, and Idaho who are eighteen (18) years or older at the time of entry and are current Avista residential customers (“Participants”). This Promotion is void where prohibited by law.

Employees, temporary employees, independent contractors and interns of Avista, and its respective subsidiaries, including its officers, directors, employees and agents (hereafter “Avista”) are not eligible to enter or to win.

HOW TO ENTER: Participants may enter to win one (1) of one hundred (100) \$100 Avista bill credits (“Prize” or “Prizes”) by enrolling in paperless billing through their Avista account online at www.myavista.com (as also linked in email sent to eligible participants) or by enrolling through an Avista Customer Service Representative by calling (800) 227-9187.

DEADLINES: The promotion begins at 12:00 a.m. PT on Tuesday, July 28, 2026, and ends at 11:59 p.m. PT on Wednesday, September 30, 2026 (“Promotion Period”). No submissions will be accepted after the deadline for any reason. The sole determinant of time for the purposes of the online Promotion will be those Participants who have enrolled in paperless billing as of 11:59 p.m. PT on September 30, 2026. Participants enrolling in paperless billing close to the posted deadline should bear this in mind.

RULES: Avista is not responsible for any lost, late, misdirected, or incomplete paperless billing enrollments or for any computer, online, telephone or technical malfunctions that may occur.

Paperless billing enrollments will be deemed completed by the authorized account holder at the time of enrollment completion. “Authorized account holder” is defined as the person who is assigned to an email address by an internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. Only one paperless billing enrollment is allowed per Avista account.

ODDS OF WINNING: Odds of winning depend on the number of eligible paperless billing enrollments completed.

PRIZES: One hundred (100) individual winners will receive one (1) \$100 Avista bill credit.

Prizes are non-transferable and may not be redeemed for cash; substitutions may not be requested. Prizes are not eligible for Avista rebate submission. By participating in the promotion and accepting a Prize, Participants agree to abide by these Official Rules. Each winner is responsible for all applicable federal, state, and local income and any other taxes, fees and surcharges, as applicable. An IRS Form 1099 will be issued for all prizes with a retail value in excess of \$600 USD. Avista reserves the right to substitute a prize of equal or greater value.

Mission, Spokane, WA 99202 from all qualified paperless billing enrollments completed by the deadline. Winner selection will be made by Avista, whose decision shall be final. Winners will be contacted directly by Avista via email. If a winner is unreachable after two (2) business days, an alternate winner will be selected by a random drawing from the remaining qualified entries. In order to be named a winner, potential winners must have completed their enrollment of paperless billing, which was completed either prior to or within the Promotion Period. Noncompliance will result in disqualification and an alternate winner will be selected.

CONDUCT: By entering the Promotion, Participants agree to be bound by these Official Rules. The Official Rules are posted throughout the Promotion Period. Participants further agree to be bound by the decisions of Avista, which shall be final and binding in all respects. Avista reserves the right at their sole discretion to disqualify any individual if they are found to be tampering with the entry process or the operation of the Avista website or to be acting in violation of the Official Rules. Participants agree not to use obscene, libelous or slanderous language, or language that infringes upon a third party's trademark, trade name or other intellectual property right or right of privacy while participating in the Promotion.
