Purpose To achieve meaningful energy efficiency improvements on projects identified by the EAG as high priority.

Annual \$500,000 (with flexibility for project completion). Amount

Requirements Funds can be used towards a measurable Energy Efficiency project and/or with Health, Safety and Repairs.

Equity Advisory Group Brainstormed Ideas (December 2022)

Major themes (strategies) included:

Increase electric vehicle charging infrastructure for and within named communities

- Increase EV charging in rural places
- Ride share in rural communities in combination with EV
- More EV charging in places without access
- o Multi-family charging infrastructure
- Education for landlords on EV charging options
- Find ways to encourage landlords to add charging
- Address policy barriers to increasing charging infrastructure
- Increase tree canopy and shade in named communities through "Community greening"

- Plant trees in named communities
- Plant more trees
- o More native plants
- Planting native shade trees (Gonzaga has data to help guide location City of Spokane partnership in planting of the trees)
- o More plant diversity
- o Community gardens to increase greenspace and provide food

 - o Increase rebates for appliances gave furnace example
 - Battery operated light bulbs

Criteria











Leverage: Does the activity address the most important root causes identified? Does it have the greatest potential impact on the performance measures for the strategy?



Feasibility: Is it within our reach? Do we have the resources and time? Is it within the ability of the stakeholder group?





Specificity: Is the activity specific enough to be implemented?






Values: Is the strategy consistent with the values of the group?
