The following rebates are available for the ENERGY STAR/ECO-Rated Homes Program. Please see Additional Conditions for complete rebate requirements. All programs are subject to change. Request for rebate must be submitted within 120 days of home occupancy. Offers apply to newly constructed manufactured homes and may not be combined with any other Avista rebate within a 12-month period of home occupancy.

Customers with Avista natural gas service only, with electricity from another provider, are eligible for a **\$600 rebate**.
Customers with Avista electric only or with Avista electric and natural gas are eligible for a **\$1000 rebate**.

Additional Conditions

1. Request for rebates must be submitted within 120 days of home occupancy.
2. The rebates listed are applicable to **new construction manufactured and modular homes**.
3. Rebate eligibility is dependent on which services (natural gas, electric or both) the customer receives from Avista.
4. Rebates are not available for seasonal or recreational homes; homes must be primary living residence.
5. Primary fuel used for space and/or water heating must be Avista electric or natural gas service to qualify.
6. This rebate may not be combined with any other Avista rebate available within a 12-month period of home occupancy.
7. Homeowners are responsible for complying with all applicable codes and regulations.
8. Avista reserves the right to inspect energy efficiency measures prior to payment and will coordinate inspection as applicable.
9. Avista may upon reasonable notice access customer's premises to verify the installation is in compliance with this Agreement.
10. Allow 6 to 8 weeks for processing and payment of rebate.
11. A copy of ENERGY STAR®/ECO-Rated Homes certificate must be submitted for ENERGY STAR/ECO-Rated Homes rebate.

ENTIRE AGREEMENT/APPLICABILITY/ASSIGNMENT.

This Agreement contains the entire agreement between Avista and the Participant and may not be modified except by a written instrument signed by both parties. Furthermore, this Agreement will be binding upon the successors and assigns of such parties. Participant may not assign this Agreement without prior written consent of Avista, which consent will not be unreasonably withheld. Avista may assign their agreement at its sole option.

ATTORNEYS' FEES. If any action is brought to enforce this Agreement, the prevailing party in such action will be entitled, in addition to any other relief, to an award of reasonable attorneys' fees and costs incurred in such action.

VERIFICATIONS. Avista has the right to verify equipment installed on the Premises at its option upon reasonable notice to the Participant.
