With this change, Avista is increasing its Idaho electric base rates to include its additional investment in the Coyote Springs 2 (CS2) generating plant as well as the associated operating costs, reflecting its purchase of the second half of the CS2 project from Mirant. Avista is also decreasing, by an offsetting amount, its PCA surcharge revenues. With that offset, the net effect is no change in retail rates for customers.
