These changes are primarily to implement a Purchase Gas Adjustment (PGA) to adjust Avista Utilities' tariff schedules to reflect the projected cost of gas pursuant to Tariff Schedule 462 (Purchased Gas Cost Adjustment provision). Schedule 462 allows the Company to adjust the rates within its service schedules for changes in the estimated purchased gas costs for the forthcoming year, and the amortization rate(s) pertaining to the PGA balancing accounts, as well as other deferred accounts related to costs associated with DSM (conservation) programs.

This change implements an overall revenue increase of approximately \$23.2 million (22.5%) annually. FA residential customer, using 53 therms of natural gas per month, will see a monthly increase of \$13.70.

The purpose of these changes is to initiate a new Purchased Gas Cost Adjustment (PGA) Schedule to be in effect for the six-month period April 1, 2005 through September 30, 2005. Avista's present PGA Schedule, Natural Gas Benchmark Mechanism (Schedule 464), expires on March 31, 2005. The expiration of Schedule 464 falls in the middle of a PGA review period (October 1–September 30). Given the expiration date of Schedule 464, as well as the Commission's current investigation of the PGA process, Avista and OPUC Staff agreed the PGA provisions set forth in the proposed Schedule 463 were the most reasonable and expeditious means of establishing deferred gas cost provisions for the Company.
