**Proposed Natural Gas Rate Adjustment  
to be Effective Nov. 1, 2019**

Avista has filed a natural gas rate request with the Idaho Public Utilities Commission (Commission), with a requested effective date of Nov. 1, 2019. This annual filing is separate from the general rate case request filed in June 2019 regarding base retail rates in Idaho and has no impact on the company's earnings.

The rate request is the annual Purchased Gas Cost Adjustment (PGA). The PGA is filed each year to balance the actual cost of wholesale natural gas purchased by Avista to serve customers with the amount included in rates. This includes the natural gas commodity cost as well as the cost to transport natural gas on interstate pipelines to Avista's local distribution system. This rate adjustment is driven primarily by higher wholesale natural gas prices in the 2018-2019 winter season, which were caused, in part, by a Canadian pipeline disruption that restricted natural gas flows into the Pacific Northwest. If approved, Avista's request is designed to increase natural gas revenues by \$3.3 million or 5.6 percent.

**Customer Bills** - If approved, residential natural gas customers in Idaho using an average of 64 therms per month would see their monthly bills increase from \$47.62 to \$49.88, an increase of \$2.26 per month, or approximately 4.8 percent. The proposed natural gas rate change would be effective Nov. 1, 2019. The requested natural gas rate change by rate schedule are:
